## **Year 7 Scholarships and Bursaries**

- Applications open Monday 12 February
- Applications close 4.00pm Friday 23 March

Bayview College awards Scholarships and Bursaries to young people who would benefit from, and contribute to, education at Bayview College.

Scholarships and Bursaries are awarded to young people who demonstrate potential for a commitment to the Vision and Mission of the College.

Scholarships and Bursaries are awarded annually to students entering Year 7 for up to four years, with the possibility of extension into the Senior Years. Scholarships and Bursaries will cover up to 50% of tuition fees.

Students awarded scholarships will be bound by the same rights and responsibilities as all students at Bayview College.

## **Criteria for Awarding Scholarships**

Bayview fosters the expectation that each student will become the best person he or she can be. In making its decision, the Scholarship Selection Committee considers the following criteria: as well as impressions gained at interview, latest school reports and references:

### **Academic Excellence**

- Evidence of academic excellence in any of the core subject areas
- Impressions gained at interview.

Applicants are required to sit a comprehensive academic test at Bayview. Parents/applicants are notified of the outcome by mail or phone.

### **Creative, Visual & Performing Arts**

Evidence of potential talent in any of the following areas:

- Art/Design
- Drama
- Music
- Design & Technology

Applicants are required to sit the academic test at Bayview. Applicants are also required to demonstrate ability via the submission of a folio or a performance audition. Parents/applicants will be notified of the outcome by mail or phone.

## **Physical Education, Sport and Outdoor Education**

Evidence of potential talent in any of the following areas:

- Physical Education
- Sport
- Outdoor Education

Applicants are required to sit the academic test at Bayview. Applicants are asked to submit a portfolio of their sporting/recreational achievements with this application. Parents/applicants are notified of the outcome by mail or phone.

## **School & Community Involvement**

- Involvement in Primary School and Local Community
- Evidence of ongoing participation in extra-curricular activities and engagement with the local and wider community

Applicants are required to sit the academic test at Bayview. Applicants are asked to submit a portfolio of their achievements and evidence of involvement with this application. Parents/applicants are notified of the outcome by mail or phone.

## **Criteria for Awarding Bursaries**

Bayview fosters the expectation that each student will become the best person he or she can be. In making its decision, the Bursary Selection Committee considers the following criteria:

- Letter from Student providing a personal statement outlining how they believe they can contribute to and benefit from a Christian education at Bayview (200 words).
- Reports from current school
- 3 referees (ideally 1 from a Minister of Religion / School Chaplain)
- Confidential demonstration of need
- Completion of Creative Writing piece
- Impressions gained at interview

Students applying for a Bursary are not required to complete the entire academic testing process.

## **Scholarship and Bursary applications should include:**

1. Applicant's School Report for the end of the previous academic year & latest NAPLAN results.
2. Names and contact details of 2 referees (3 for bursaries) and where possible, a letter of reference to validate and support the application. These could include the primary school principal or teacher, community leader, church minister, sporting coach or club leader.
3. Portfolio of achievements, certificates/examples of your work in your specialised area.

## **Conditions of Acceptance**

Students who accept a scholarship or a bursary agree to be committed to their personal educational progress consistent with the Bayview College Vision and Mission Statement and take personal responsibility to accept and live our standards and expectations.

## **Scholarship Application**

- Scholarships of up to 50% of tuition fees are awarded to young people who demonstrate potential for a commitment to the Vision and Mission of Bayview College.
- They are awarded on the basis of a range of criteria that take into account the merit of eligible students.
- Scholarships are awarded annually for students entering Year 7 for up to four years – dependent upon an annual review of performance. Students may re-apply in Year 10 for VCE/VCAL Scholarships.
- Students awarded scholarships are bound by the same rights and responsibilities as all students at Bayview College.

## **Bursary Application**

- Financial bursaries are granted to young people who demonstrate potential for a commitment to the Vision and Mission of Bayview College; whose families wish for a Christian education for their son/daughter, but whose financial position may make this difficult to achieve.
- Students who apply for a bursary will not be required to sit an academic test, but will participate in the interview process

## **Privacy Policy**

This statement is taken from the Bayview policy on how the College uses and manages personal information provided to or collected by it. The College is bound by the National Privacy Principles contained in the Commonwealth Privacy Act. The College will, from time to time, review and update this Privacy Policy to take account of new laws and technology, changes to College operations and practices, and to make sure that it remains appropriate to the changing legal environment.

The type of information that the College collects and holds includes (but is not limited to) personal information, including sensitive information, about:

- other persons who come into contact with Bayview

## **Information provided to Bayview**

The College generally collects personal information held about an individual by way of forms filled out by parents or students, face-to-face meetings and interviews, and telephone calls. On occasions persons other than parents and students provide personal information.

In some circumstances the College may be provided with personal information about an individual from a third party, for example a report provided by a medical professional or a reference from another school.

## **Use of Information Provided**

The College uses personal information it collects for the primary purpose of providing an education and appropriate program of instruction according to its Vision and Mission. The purposes for which the College uses personal information on students and parents include:

- to keep parents informed about matters related to their child's schooling, through correspondence, newsletters and magazines;
- day-to-day administration;
- looking after students' educational, social and medical wellbeing;
- seeking donations and marketing for the College;
- to satisfy legal obligations and allow the College to discharge its duty of care.

In some cases where the College requests personal information about a student or parent, if the information requested is not obtained, the College may not be able to enrol or continue the enrolment of the student.
